# Meals On Wheels Is In Motion!

### MOW—bringing Independence, Connection, & Delicious Meals to our Upper Perk Seniors

Many of you are familiar with our food-based services, including food pantry at our Penn Street location and our Monday-Friday Community Lunch at our Senior Center. But what happens when a senior is unable to shop for themselves, prepare meals, or utilize our other food-based services? Thankfully, our Meals on Wheels (MOW) Program helps to serve our most vulnerable seniors in need!

Meals on Wheels provides home-delivered, nutritious, and well-balanced meals to older adults in our community 60 and above. Currently, the requirements to apply for Meals on Wheels in Montgomery County are as follows: the individual must reside in Montgomery County, be age 60 or older, must be unable to prepare meals for themselves, must be unable to shop for themselves, and must have no supports residing with them or visiting regularly to provide meal preparation and shopping support. Currently, there is no incomebased requirement, though Montgomery County's informational page on Home Delivered Meals does now note a focus on "impoverished" older adults in Montgomery County.

Meals on Wheels is not only an opportunity for a daily, day-brightening visit, but is also a safety check, providing peace of mind to participants and their loved ones, as well as helps participants remain independent in their homes longer.

Currently, we serve 35 seniors, a significant increase from our number of participants last year. While our current program and enrollment is smaller than other local MOW programs, over the past fiscal year, on average, the meals for MOW alone still cost us \$4.800 per month. Unfortunately, while we do receive a small amount of funding for MOW from Montgomery County, The Open Link is directly responsible for the administrative and operations costs ourselves. That means that the amount received from the county does not fully help homebound seniors - so we are dependent upon your generous donations to keep this program running. Beyond financial contributions, we would also love it if you would volunteer to be a weekly



driver, sub driver, or sub packer!


It is also important to know that Montgomery County's Office of Aging Services (MCOAS) runs the approval process for this program, where participants and families are required to complete both a phone assessment by enrollment and a home visit by a care manager prior to approval for Meals on Wheels. However, we are often the first point of contact from consumers or loved ones about MOW, and we review the individual's qualifications, send eligible referrals to the county, and if approved, we are quickly able to enroll participants in our MOW program.

If an applicant is not initially approved for MOW, we are able to follow up with a consumer or their loved one, email the enrollment supervisor, and if someone is still rejected, they are eligible for our food pantry services and Community Lunch. While you can call MCOAS directly, we'd still love to chat with you to get to know you, understand qualifications and the process, and help you if you have any issues – we're here for you!




## From Capitol Hill to the Upper Perk Valley

How Federal Decisions Will Impact Our Work

medium income, which is \$101,000 in months, many people have asked me Montgomery County for a family of 4. if The Open Link will be impacted by decisions being made at the Federal level. Like many of my counterparts, I can truthfully say that I am unsure as to how decision making happening at that level will impact the organization.

To address some of the concerns I'm hearing, I would like to share the areas that we consider vulnerable to proposed and implemented cuts. This way, our readers can understand a bit more of how we work in connection with other programs and services to provide help for our neighbors.

Over the course of the last few

There are several federal programs that we rely upon, both directly and indirectly, that are in jeopardy now. These programs are designed to help those with low-incomes or very lowincomes, from 50 to 80% of the area's

So who is considered low- and very low-income in our community? From the School District, we have data that identifies about 36% of students living in low-income households. From census reports, we also see that about 8% of the adult population in the four municipalities (Pennsburg, Red Hill, East Greenville, and Green Lane) live in low-income households. Additionally, about 3% of our seniors are low- or very low-income.

Some federal programs, like TEFAP (The Emergency Food Assistance Program), have already been discontinued. TEFAP provided about 10% of the food that The Open Link distributed to households in need each year through the pantry. We will need to look at other ways to fill this

support, households who currently receive LIHEAP (the Low-Income Home Energy Assistance Program) could lose these benefits in the winter of 2025. LIHEAP provides help with heating bills for about 346,000 Pennsylvanians each year in the form of a one-time grant of about \$200 to \$1,000. While LIHEAP is administered by Pennsylvania, the funding is appropriated by Congress. Right now, there is a freeze on that funding due to staffing cuts at the Federal level, as well as a proposal to cut the program altogether. While The Open Link operates a small

utility and rental assistance program that helps our neighbors with a utility bill or rent in an emergency, our role is mostly to help low-income Valley residents, particularly seniors, register for LIHEAP each winter. If the program no longer exists, The Open Link will struggle to support those in need of heating assistance. Our utility and rent support fund is approximately \$25,000 thanks to several grants, helping about 165 people with rent and utility assistance each year. We anticipate that we would need to double this budget to support those who would not be able to access LIHEAP next year.

Other cuts that are not tied directly to The Open Link but could have a significant impact include proposed decreases in the SNAP

(food stamp) program and cuts to Medicaid. In our community, the majority of those individuals using both programs are our neighbors over 60 who are very low-income. or those who have less than 50% of the median household income in our area. Many already live in lowincome communities and have very limited fixed incomes.

Without cuts, the charitable food system can realistically provide 1 meal to every 8 meals provided by SNAP. If SNAP is cut significantly or discontinued, The Open Link and other pantries like us will be overwhelmed in trying to meet the needs of the community and will struggle to fill the gap left without SNAP. In addition, nutrition and



health for those on SNAP would also be in jeopardy, as it provides much of the fresh and perishable foods that pantries struggle to keep on hand. Additionally, without proper medical care or the ability to afford medications, our seniors will struggle with their health and other related impacts.

Adding the loss of Medicaid with the possible loss of SNAP and LIHEAP, our seniors and children in particular will suffer medically nutritionally, and in many other

In sharing this news, it is not my intention to create a gloom-anddoom scenario, but rather to share the nature of this symbiotic relationship with the other programs designed to support our most



vulnerable community members. It is also an opportunity to emphasize the vitality of The Open Link in this community. While policies and programs ebb and flow, our small-but-mighty social services organization will continue to adapt and work to support the community in the best, most innovative ways possible. The Open Link was created by this community, FOR this community. With that focus in mind, we will support its most vulnerable members as long as the community believes it is important.
